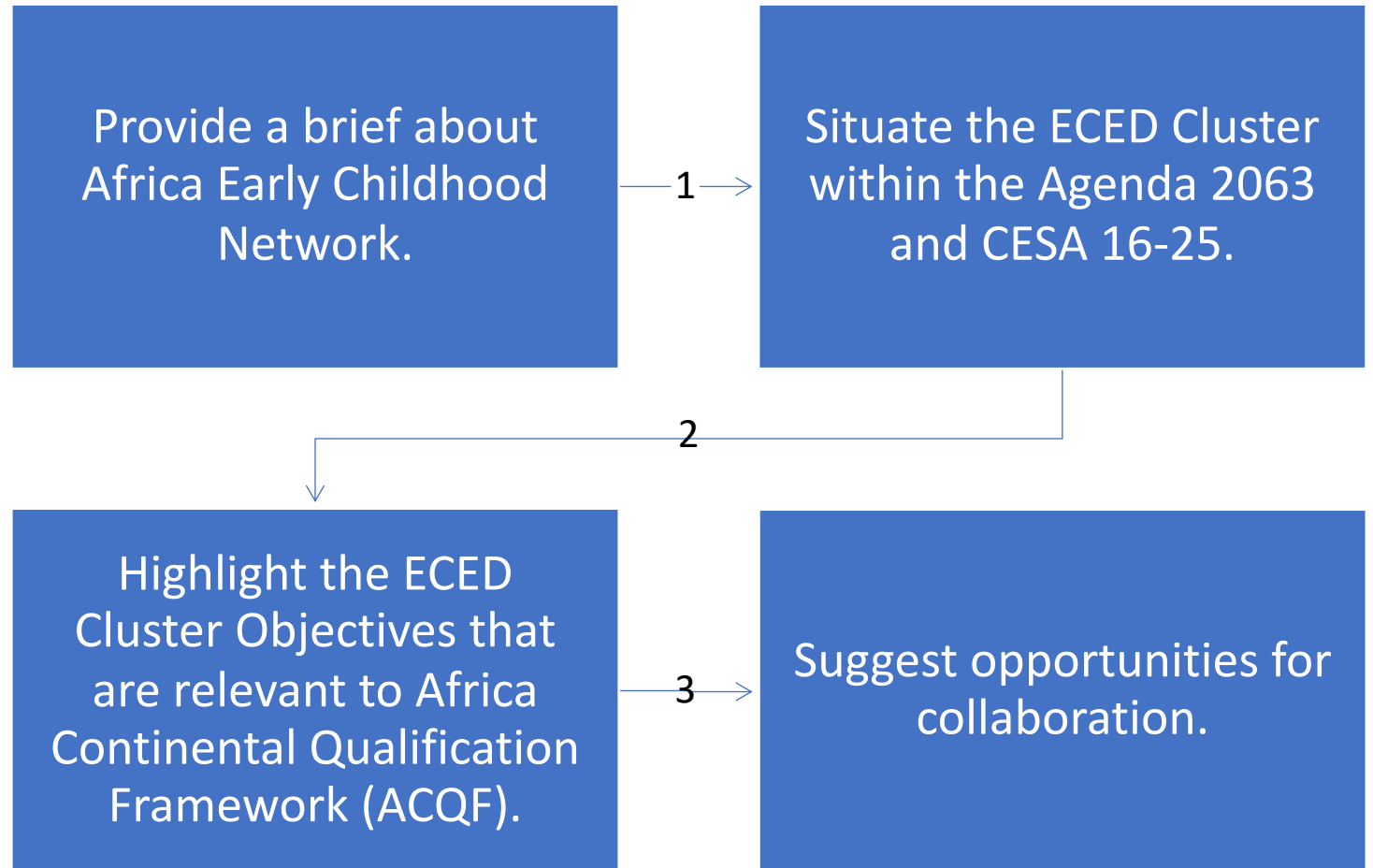

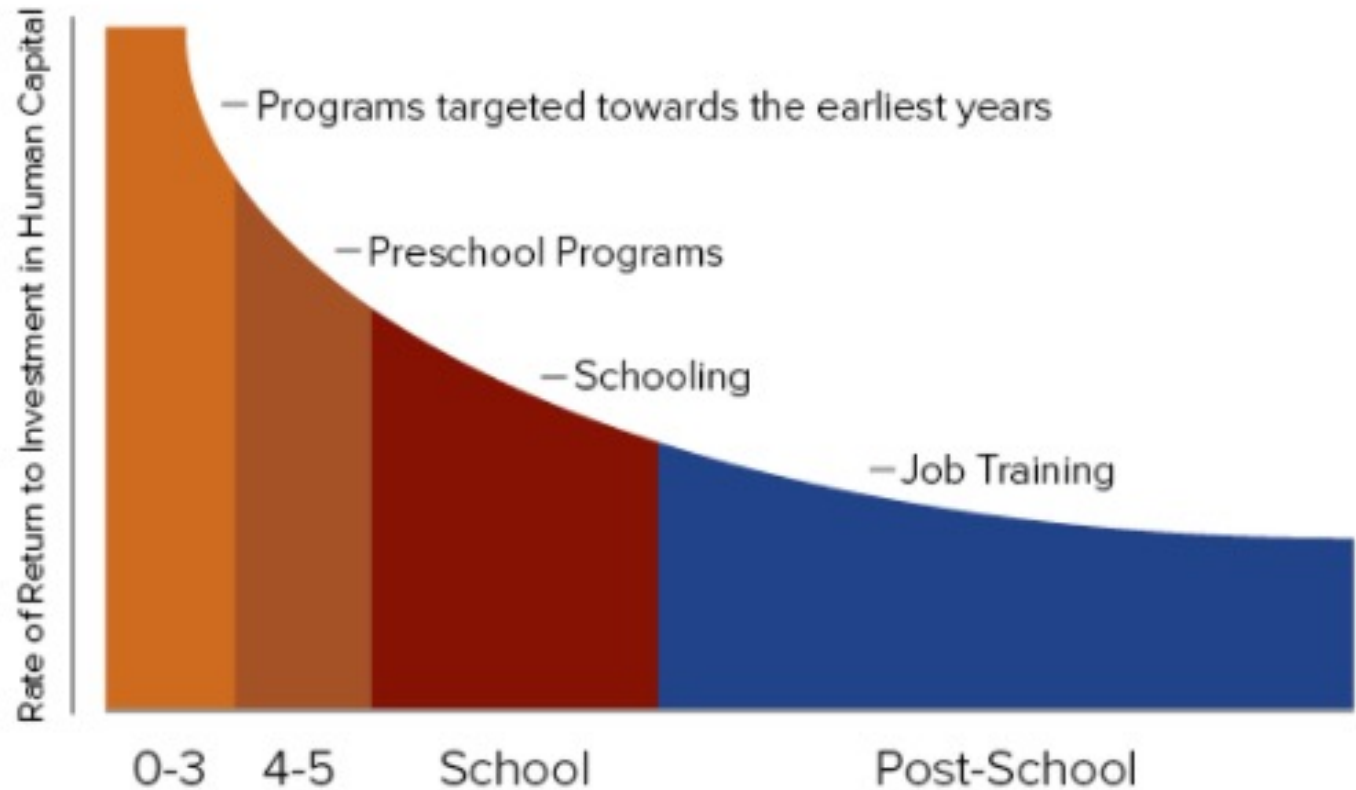


# Why invest in Early Childhood Development

Investment in child health, care and education during early years provides a critical foundation for accumulation of human capital needed to realize their potential as productive members of society.

Better human capital outcomes are associated with higher earnings for people, and better socio-economic development of a nation.

Returns to a Unit Dollar Invested are Highest in Earliest Years

# ECED Cluster

---

Agenda 2063 calls for universal access to quality early childhood, primary and secondary education, ensuring that no child is left behind, and that the potential of every child is nurtured.

---

CESA16-25 identifies pre-primary education as a neglected sub-sector that deserves special attention.

---

CESA 16-25 recognizes Early Childhood Education and Development (ECED) as the pillar for future learning and identifies ECED as the next frontier if Africa is to realize sustained quality education and training.

---

To support implementation of the continental framework (CESA16-25) objectives related to early years, the African Union Commission (AUC) launched the ECED Cluster on 4th September 2018.

# ECED Cluster Objectives

## **Objective 1:** Enhance Policy, Advocacy and Communication.

- 1.1 Increase advocacy to strengthen political will and financing for policy development and sustainable implementation of strategies.
- 1.2 Enhance Policy Development

## **Objective 2:** Intensify action to improve equitable access to quality. ECED programmes and services.

- 2.1 Enhance advocacy for equitable access to quality services.
- 2.2 Improve early learning infrastructure.
- 2.3 Increase ECED programmes and services

## **Objective 3:** Improve Quality of ECED systems, programmes, and services.

- 3.1 Strengthen the capacity of the ECED workforce.

- 3.3 Enhance quality assurance and assessment mechanisms.

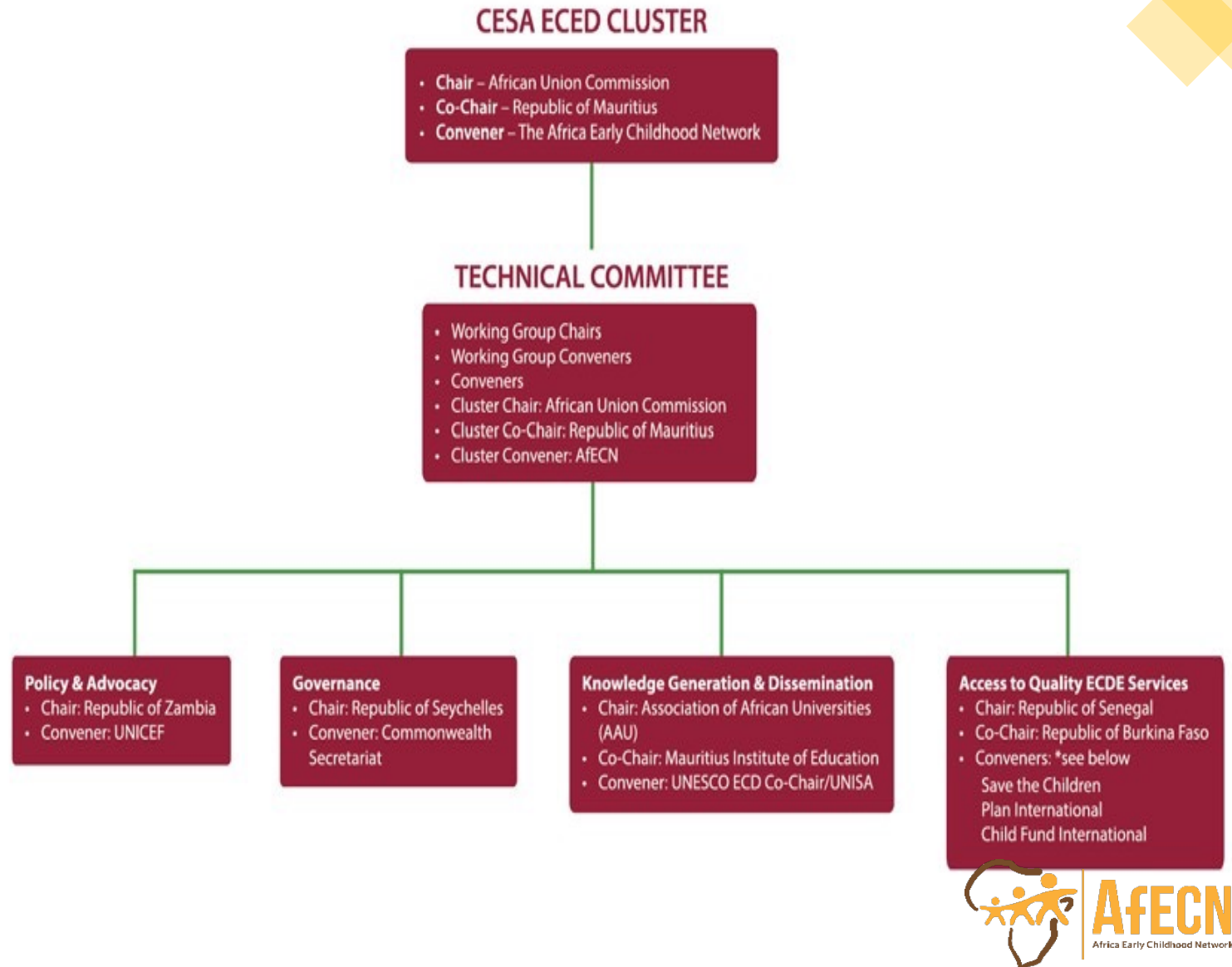

# How ECED Cluster is Structured

- The Cluster is chaired by the African Union Commission, with the Government of Mauritius as the Co-Chair.
- The African Early Childhood Network (AfECN) acts as coordinator and secretariat to the Cluster.
- To operationalize the cluster and further streamline operations, a technical committee and four working groups were established.
- ECED Cluster working Groups
  - Policy, advocacy, and communication;
  - Governance and accountability;
  - Access to quality ECED services; and
  - Knowledge generation and dissemination.
- Each working group has a Member State serving as chair and a development partner as the convener.
- The chairs and conveners of each working group as well as AUC, AfECN and ICQN together form the technical Committee.





# ECED Cluster Objectives relevant to the Africa Continental Qualification Framework (ACQF) Project

<b>ECED Cluster Objective 3: Improve Quality of ECED systems, programmes, and services.</b>	
<b>3.1</b>	<b>Strengthen the capacity of the ECED workforce</b>
3.1.1	Conduct a landscape analysis of the ECED workforce across the region
3.1.2	Develop regional workforce development strategy (including career path, continuous development, good working and living conditions)
3.1.3	Develop a framework for implementation of a strategy for continuous professional development
3.1.4	Recruit, train, and deploy well qualified teachers as well as promote their continuous professional development with emphasis on instilling core values, results and accountability to learner's skills and competencies as well as mobility across the sub-sector.
3.1.5	Capitalize on existing and successful ICT-driven initiatives that enhance access to training including the Pan-African E-University
3.1.6	Develop quality and relevant teaching, play and learning materials and resources
3.1.7	Create mobile and online education and training platforms and accessibility to all students regardless of their circumstances
3.1.8	Identify and reward dedicated and innovative ECED teachers
<b>3.2</b>	<b>Support relevant and comprehensive regional and national curricula</b>
3.2.1	Design and support adoption of a regional ECED curriculum framework that includes emerging issues such as peace education, conflict resolution and HIV
3.2.2	Develop guidelines to strengthen national implementation of ECED curricula
3.2.3	Strengthen national curricula including gender sensitive ECED training curricula, to provide the foundation for development of life skills, creativity and other key competencies
3.2.4	Develop and support the national adaptation and institutionalization of a regional framework for assessment of school readiness
<b>3.3</b>	<b>Enhance quality assurance and assessment mechanisms</b>
3.3.1	Develop and implement a national quality improvement framework and roadmap
3.3.2	Set up national qualification frameworks (NFQs) and regional qualification frameworks (RFQs) to facilitate the creation of multiple pathways for professional development
3.3.3	Establish and strengthen quality assurance mechanisms to support systems strengthening and improved child outcomes
3.3.4	Provide implementation support to ensure ongoing monitoring, learning, evaluation, and improved programming



# Key milestones related to ECED Teacher Qualification

- ❑ Conducted Analysis of Early Learning Workforce in Sub-Saharan Africa;
- ❑ Developed a guideline for improving quality and capacity of ECED Workforce in Africa;
- ❑ Participation in Teacher Development cluster activities, including sharing of best practices to improve ECED teacher qualification and professional development across the region;
- ❑ Strengthening capacity of National Advocacy Partners ( NAPs) in 17 African countries to support and provide input to ECED policy development and implementation including improvement of ECED workforce development.

# Opportunities for Collaboration with ACQF

- Dissemination of AfECN guidelines for improving quality and capacity of ECED Workforce in Africa;
- Analysis on the extent of integration of ECED into National Qualification Frameworks;
- Development of regional workforce development strategy (including career path, continuous development, good working and living conditions)-**ECED Cluster objective 3.1.2;**
- Setting up of national qualification frameworks (NFQs) and regional qualification frameworks (RFQs) to facilitate the creation of multiple pathways for professional development-**ECED Cluster objective 3.3.2**
